

# ANOMALIJSKI PRIRAŠTAJ MAGNETSKOG POLJA JEDAN OD UZROČNIKA KARDIOVASKULARNIH OBOLJENJA

## SAŽETAK

Čovek je nastao, živi i umire u prirodnom Zemljinom magnetskom polju (ZMP), međjutim enormni intenziteti ZMP izazivaju štetne posledice na ljudski organizam.

Cilj ovog rada je doprinos etiopatogenezi kardiovaskularnih bolest (KVB) nastalih pod uticajem enormnih intenziteta ZMP, izmenjenih prirodnih vrednosti tj. anomaljskih zona (Az). Izvršena su ispitivanja kako Az deluju patogeno izazivajući oboljenja.

Utvrđena je veza između Az i KVB. Otkriven je uticaj Az na organizam čoveka a zatim je čovek uklonjen izvan uticaja tih Az praćeno je zdravstveno stanje organizma.

Da bi se došlo do navedenih rezultata bila je neophodna objektivna procena primenljivosti korišćene geofizičke metode. Tom prilikom izvršena je sinteza dve grupe podataka. Obradom prve grupe podataka utvrđena je korelaciona veza između prisutnih Az i regije tela zahvaćenog oboljenjem. Druga grupa podataka su teorijska objašnjenja nadjenih nejasnoća u literaturi o KVB sa aspekta poznavanja magnetskih osobina. Utvrđena je podudarnost praktičnih rezultata merenja i teoretskih objašnjenja mnogih nejasnoća.

## THE ANOMALOUS INCREASE OF MAGNETIC FIELD AS ONE OF THE CARDIAC-VASCULAR DISEASES CAUSES

### ABSTRACT

*Human beings are born, live and die in the natural Earth's magnetic field.(EMF). However, EMF enormous intensities have harmful effects on human organism.*

*This work's aim is to contribute to the etiopathogenesis of cardiac-vascular diseases (CVD) occurred under the influence of EMF's enormous intensities, of the changed natural quantities, i.e. anomalous zones (Az). There have been performed researches on how Az acts pathogenetically causing diseases.*

*A correlation between Az and CVD was discovered. The influence of Az upon human organism had been found and then the affected person was moved out of the AZs reach and his health condition was observed.*

*In order to achieve the mentioned results, an objective evaluation of the used geophysical methods applicability was necessary. Thus, synthesis of two groups of data was performed. Processing the first data group showed a correlation between the present Az and the part of the human body affected by the disease. The second data group are theoretical explanations of the obscurities found in the literature on CVD, from the magnetic field concept's point of view. A complete compatibility of the practical measuring results and theoretical explanations of many obscurities has been found.*
